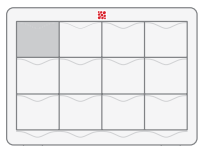
- Portable and stackable

- Each module consists of 1-12 drawers and can be configured in 1 size, 2 size and 4 size single deep and 2 size double deep drawers



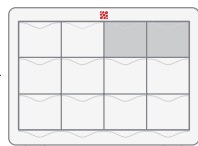

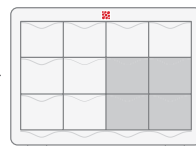

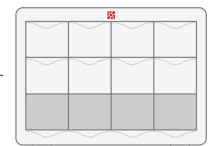
1 Size Drawer: Single Deep

W 165 mm x H 127 mm x D 223 mm

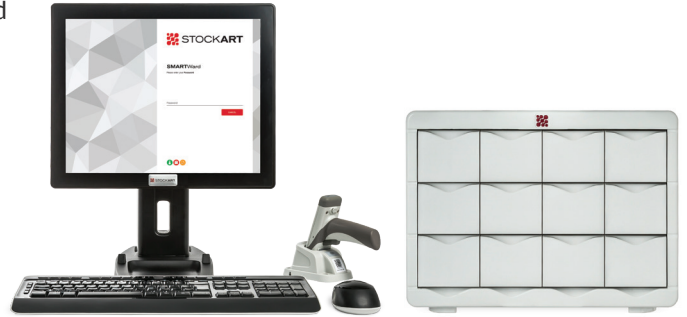


4 Size Drawer: Single Deep

- Enables temperature and humidity monitoring

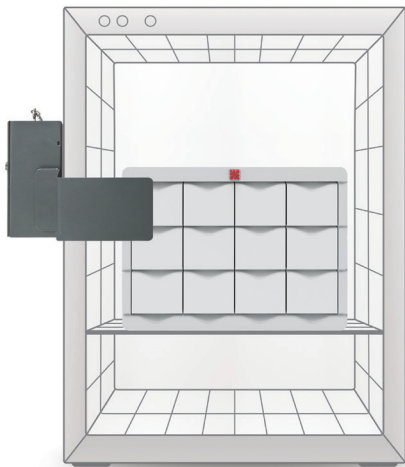


MedNest® for Cold Chain: Secure Cold Chain Management

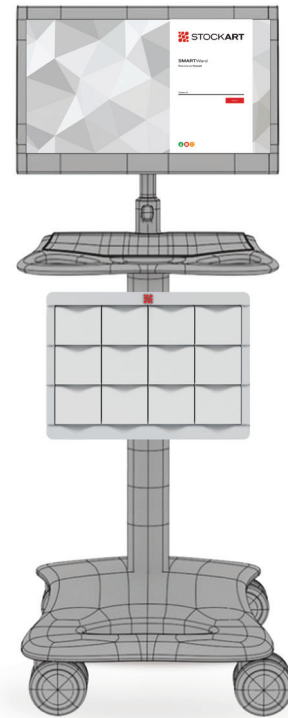
The **MedNest® for Cold Chain** smart drawer unit is placed in the fridges used in hospitals.
